WHEREAS in terms of Section 14(1)/Section 15(1) of the NCTE Act, 1993 KUNBI SHIKSHAN PRASARAK SANSTHA SANCHALIT, SENIOR COLLEGE OF EDUCATION, PLOT NO. 68 B, KHATA NO. 14, VILLAGE- BHARNE NAKA, RATNAGIRI MAHARASHTRA (name of the Institution/Society) has submitted an application (Code No. APW01997/123282) to the stern Regional Committee of NCTE for grant of re cognition/permission for starting B.ED. course of one year duration with an annual intake of 100 (Hundred) (Secondary) students.

- NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act. 1993. the Western Regional Committee hereby grants recognition to KUNBI SHIKSHAN PRASARAK SANSTHA SANCHALIT, SENIOR COLLEGE OF EDUCATION, PLOT NO. 68 B, KHATA NO. 14, VILLAGE- BHARNE NAKA, RATNAGIRI MAHARASHTRA (Name of the Institution/Society) for conducting B.ED. course of one year duration with an annual intake of 100 (Hundred) (Secondary) students under clause 7(10) of Regulation dated 13-1-2005 (if plicable) subject to fulfillment of the following:
  - 1. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Western Regional Committee.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- III. That the institution shall obtain an unconditional letter of recognition in terms of 7(12) of NCTE Regulation 13-1-2005 (if the recognition is being granted under 7(11).
